- Oral Presentation Criteria (25% of the total score):
 - Ideas show preparation and clarity
 - Voice quality is clear, audible volume
 - Eye contact and body language
 - Professional appearance
 - Address the following points and include any other material that would provide insight into the creation of the video:
 1. Why did you choose this topic?
 2. How did you hope to affect your audience with your story (emotions, opinions)?
 3. What elements did you include in your video that would produce those effects?
 4. The creative process includes making artistic choices, resolving production challenges, and reconciling differing points of view. Please summarize how your team dealt with these issues.
 5. What advice would you give to a novice film-maker who was just beginning a project of this type?
